ENROLLMENT POLICIES AND INFORMATION

REGISTRATION AND ENROLLMENT

Summer registration, after the early enrollment date, requires a \$20 summer registration fee. All class times/teachers are subject to change.

ATTENDANCE & MAKE-UP LESSONS

Regular attendance is expected of all students. No private lesson will be made up except for:

- Student illness: MusicMakers must be notified by 10:00 am on the day of the lesson to qualify for a make-up lesson. *Only one lesson per semester will be made up.*
- Teacher absence: Any lesson missed as a result of the teacher's absence will be made up.

Make-up Lessons

Teachers will offer two alternatives for make-up days or a group lesson option where appropriate, before lessons are forfeited.

- All make-up lessons are arranged through the instructor.
- All make-up lessons for student illness will be forfeited upon early withdrawal.
- All makeups must be completed during the same semester the absence occurred and cannot be rolled over into another semester.

BILLING & PAYMENT SCHEDULE

Payment is due in full upon registering, OR we require a credit card or postdated checks for each month given to us at the time of registering. Students may not start lessons until this condition has been satisfied. ***Please note: We DO NOT invoice – it is up to the responsible party to make payment in full on time using one of the two methods described above. Unpaid bills will result in late fees (see Late Payment Policy Below).***

Unpaid bills may result in the suspension of lessons, and balances must be paid in full prior to registering for a new year or for additional lessons. Questions regarding billing or current account information should be directed to the Business Office.

ALL RETURNED CHECKS WILL BE ASSESSED A \$35 FEE WITHOUT EXCEPTION. Payments are made the 1st of each month.

Lesson Withdrawal/Refund Policy: In order to withdraw and receive financial credit, students must submit a **written** withdrawal letter to the MusicMakers, LLC office. Notice to the instructor is not sufficient. Non-attendance does not constitute a withdrawal, and no deduction is made for temporary absences. The policy is based on the assumption that the student has paid the tuition in full prior to the date of withdrawal. Registration is based on a semester commitment. Therefore, the remaining tuition installments are not dismissed if withdrawal occurs before the balance is paid.

Due to contractual obligations for instruction and services, our policy is based on the schedule below:

Written termination letter from student received:

before the first lesson: 100% refund
within the first 2 weeks: 60% refund
within the first 3 weeks: 40% refund
within the first 4 weeks: 20% refund
after the first 4 weeks: no refunds

Late Payment Policy: A default charge of \$20 per month of the unpaid balance will be charged if payment has not been received within ten days of the due date. Student, or parent of student in the case of a minor, shall be liable for all costs of collection hereunder - including but not limited to legal fees, office fees, and bank fees.

CHILD SAFETY AND CONDUCT

Signing on the front of this form indicates the parent/guardian's understanding and agreement as follows: For students under 18 years of age, a parent, guardian (or other responsible adult designated by the parent) should accompany the child while at MusicMakers instructional time or activities. Responsibility for each child's safe arrival, departure and for the child's safety and appropriate behavior while at MusicMakers (on or off school premises) rests solely with the parent or the parent's designated accompanying adult. Children under the age of 18 may not be dropped off/picked up more than 10 minutes prior to/after their designated lesson time. Teachers and staff are not childcare providers; please be respectful of Staff/Teachers time as they have students before and after your child(ren) and are not responsible for watching your child(ren) outside of their designated lesson time. A fee equal to an additional lesson will be assessed for unaccompanied students on premises more than 10 minutes before or after their designated lesson time.
